*WHEREAS, these figures do not include those students receiving special education services at Autumn Hill School, area private schools or in a home school setting; and*

*WHEREAS, for some people with special needs, the very things that make them unique can also keep them on the sidelines, separate from those who might not understand their differences or uniqueness; and*

*WHEREAS, it is important to promote and provide guidance to those with special needs on how to access publicly supported services available to them in the community; and*

*WHEREAS, it is important to encourage and educate the community and businesses on ways they can make facilities and services more accessible and on how to train staff to welcome and support special needs customers and coworkers; and*

*WHEREAS, the goal of this initiative is to provide a supportive and inclusive environment for individuals of all abilities by supporting community events that expand family friendly opportunities for people with special needs and their families; and*

*WHEREAS, adopting the “Celebrate #extrAAAordinary” initiative is an important statement that our City officials, business owners and residents can make to show their support for the differently-abled children and adults with special needs and their families.*

REPORT ON THE FINANCIAL STATEMENTS

*We have audited the accompanying financial statements of the governmental activities, the business-type activities, the discretely presented component unit, each major fund, and the aggregate remaining fund information of the CITY OF WASHINGTON, MISSOURI (the City), as of and for the year ended September 30, 2018, and the related notes to the financial statements, which collectively comprise the City's basic financial statements as listed in the table of contents.*

*Management's Responsibility for the Financial Statements*

*Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.*

### *Auditor's Responsibility*

*Our responsibility is to express opinions on these financial statements based on our audit. We conducted our audit in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in Government Auditing Standards, issued by the Comptroller General of the United States. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement.*

*An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the City's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the City's internal control. Accordingly, we express no such opinion. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.*

*We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinions.*

### *Opinions*

*In our opinion, the financial statements referred to above present fairly, in all material respects, the respective financial position of the governmental activities, the business-type activities, the discretely presented component unit, each major fund, and the aggregate remaining fund information of the City as of September 30, 2018, and the respective changes in financial position and, where applicable, cash flows thereof for the year then ended in accordance with accounting principles generally accepted in the United States of America.*

### *Other Matters*

#### *Required Supplemental Information*

*Accounting principles generally accepted in the United States of America require that the management's discussion and analysis and required supplemental information, as listed in the table of contents, be presented to supplement the basic financial statements. Such information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. We have applied certain limited procedures to the required supplemental information in accordance with auditing standards generally accepted in the United States of America, which consisted of inquiries of management about the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.*

*Other Information*

*Our audit was conducted for the purpose of forming opinions on the financial statements that collectively comprise the City's basic financial statements. The other supplemental information and introductory and statistical sections, as listed in the table of contents, are presented for purposes of additional analysis and are not a required part of the basic financial statements.*

*The other supplemental information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the basic financial statements. Such information has been subjected to the auditing procedures applied in the audit of the basic financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the basic financial statements or to the basic financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, the other supplemental information is fairly stated, in all material respects, in relation to the basic financial statements as a whole.*

*The introductory and statistical sections have not been subjected to the auditing procedures applied in the audit of the basic financial statements and, accordingly, we do not express an opinion or provide any assurance on them.*

**OTHER REPORTING REQUIRED BY GOVERNMENT AUDITING STANDARDS**

*In accordance with Government Auditing Standards, we have also issued our report dated March 21, 2019 on our consideration of the City's internal control over financial reporting and on our tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements and other matters. The purpose of that report is to describe the scope of our testing of internal control over financial reporting and compliance and the results of that testing, and not to provide an opinion on internal control over financial reporting or on compliance. That report is an integral part of an audit performed in accordance with Government Auditing Standards in considering the City's internal control over financial reporting and compliance.*

*RE: Artwork Placement Recommendations*

*Honorable Mayor and City Council,*

*In December 2017 the City accepted nine pieces of artwork as a donation from local artist, Larry Pogue. An agreement was made that the pieces would be placed at various public places throughout the City. The estimated value of the donation was \$71,000.00.*

*At the April 6, 2017, meeting of the Parks & Recreation Commission, the Commission voted in favor to support the recommendation of the Parks & Recreation Department and the Arts Council to hang and display two wall pieces of artwork at the Farmers Market. This motion was made on the condition that the two pieces would only be hanged, as long as the placement didn't interfere with activities associated with the Farmers Market. The artwork was never placed at the Farmer's Market.*

*In January I began working with the Arts Council and the Parks & Recreation Commission to find locations for some of the artwork, in an effort to get it out of storage and on display to the public. The Arts Council has agreed to supply the plaques, mounting clips and concrete bases for the pieces. The goal is to have the artwork on display in time for American in Bloom later this summer. Attached are pictures of the artwork and the five recommended locations.*

*Accordingly, the Parks & Recreation Commission, the Arts Council of Washington and the Parks & Recreation Department are asking for the City Council's consideration and subsequent approval for the placement of five Larry Pogue artwork pieces at various locations throughout the City.*








