Athletic Field Advertising/Sponsorship Banner Guidelines

1. Banners shall be 4'x8' for a 6' tall fence and 3'x8' for a 4' tall fence
2. All banners shall be supplied by the athletic organizations
3. Organizations is responsible for installation and removal of banners
4. Fee to the City of Washington (per banner, per season): \$50
5. Banners shall not be hung on backstops
6. Banners shall be displayed only during each organization's sports season, verified by athletic field permit issued by the Parks & Recreation Department
7. Banners are property of the athletic organization
8. City of Washington is not responsible for lost, stolen or vandalized banners

Hold harmless and Indemnification

The applicant does hereby agree to indemnify the City of Washington, its officers, volunteers, agents, representatives and employees (collectively the "Entities") and save them harmless from any loss, damage or expense arising from the claim or demand or any person to or against said Entities on account of or as a result of the applicant's Special Activity. In case of any action, or actions, or other legal proceedings, shall be brought or instituted against the City or the Entities, the applicant will assume the defense thereof, and will indemnify and save harmless the Entities against all costs, expenses, council fees and judgements resulting therefrom providing said Entities reasonably cooperate with the applicant, its agents, employees and designees in the defense of said legal proceedings or actions.

In consideration of being permitted to place a Banner at the location described above, the Permittee agrees as follows:

This Agreement constitutes the entire Agreement between the parties, and may be modified only by written agreement of the parties, and shall be governed by the laws of the State of Missouri.

In Witness whereof the parties have executed this Agreement as of the date first above written.

As the Permittee, and by my signature, I agree that I am the responsible party and fully understand and agree to adhere to and comply with all the rules and regulations, laws and ordinances of the City of Washington and Washington Parks and Recreation Department in the regard to the placement of the Banner at said location and I agree to the above indemnification.
