RE: Lion's Lake Pavilion Project Update

Honorable Mayor and City Council

I want to provide an update regarding the Lion's Lake project status. Per Council's request, I am exploring alternatives to natural rock columns for the pavilions. I found a local contractor that could install stamped concrete around the pavilion columns but could not provide column caps and could not guarantee the concrete would not crack. The estimate for 22 concrete columns is approximately \$18,000, not including caps. The columns caps would be approximately \$10,000 from a different contractor. Total for concrete columns and caps is approximately \$28,000. As you may recall, the price for natural stone and caps is \$33,770. I am currently looking into a man-made stone option but have not received an estimate at this time.

The contract for the three steel pavilions and the base bid for electric at pavilions #2 and #3 has been signed and we avoided a 5% increase in steel prices, which would have hit on June 1, 2021. During the May meeting Council requested to see if a Change Order could be taken for the Electric Alternate Bid (electric for the Grand Avenue pavilion #1) when the pavilions are being installed later this summer. The vendor said they would work with us regarding pricing and potential cost saving options for the Alternate Bid during pavilion installation later this summer but could not honor the Alternate Bid price, due to the fluctuating market.
