Bill No. 21-12485, Ordinance No. 21-13438, an ordinance amending Sections 400.100(A) and 400.100(D) of the Code of the City of Washington, Missouri.

The ordinance was introduced by Councilmember Holtmeier.

Maniaci: Good Evening, this is a proposed code amendment for the revised C-3 District downtown. There's two changes in here. In A, Intent and Purpose of the Downtown District, we've added that last sentence to say the intent of this district is to set potential growth boundaries for this historic district and to allow for mixed uses and higher densities that are

appropriate for the area and to be considered "Downtown Washington." We wanted to be clear that the revised district was actually setting growth boundaries in determining an area. Beforehand, someone on the other side of town could have asked for C-3 with really no intent in the code to say why it wasn't appropriate. Now we have that designation to say no this zoning is meant and the intent of it is for downtown.

The second change is, after discussions with the Planning and Zoning Commission and the Fire Department, there is now a Special Use. Any proposed zero-lot line on a parcel that is on a four-way intersection has to have a special review and a Special Use Permit to make sure there is no sight triangle issues. A good example is at Main and Market. Those buildings went up because had zero-lot line, and then reactively we had to bring it back to Traffic and put stop signs in. We would like to proactively be able to do that beforehand to determine....

Sullentrup: That's not a four-way.

Mayor: Yes it is.
Maniaci: It is now.
Mayor: It is now.
Patke: It is now.

Sullentrup: Oh Market...

Maniaci: Yes, Main and Market.

Sullentrup: Okay. **Holtmeier:** It is now.

Maniaci: So those are the two changers in this ordinance. Planning and Zoning did vote on this last week unanimously to approve these changes.

Mayor: Okay, any questions or comments?

Maniaci: All right, thank you.

Mayor: So, is there anyone here who would like to address the Council on this issue? It's a Public Hearing, okay.
