## Fairgrounds Tennis Courts Restoration:

- Maureen King spoke and would like the City of Washington to consider the renovation of the Fairgrounds Tennis Courts. Mrs. King came before the Park Board in 2015 and at that time, she was told the courts were shut down because the cost to repair was too much. Mrs. King stated she is a spokesperson for several people and taxpayers that support this proposal and turned in a signed petition. The group would like to see courts on the west side of town for those who do not have the capability to get to the Phoenix Tennis Courts.
- Cathy Zuroweste spoke and would like to propose the renovation of the Fairgrounds Tennis
  Courts/Pickleball Courts. Pickleball is the fastest growing sport in the United States and
  across the world right now. Pickleball is for all ages. They currently have 6-year-olds up to 85year-olds playing. Mrs. Zuroweste stated that she wants to help with the solution. Top Gun
  Storage Solutions would like to contribute \$1,000 towards the Fairgrounds court renovation.
  She also would like to reach out to other businesses and Pickleball players for donations.
- A woman, who did not state her name, stated that she home schools her children and has her 8-year-old son playing Pickleball with her; he loves it.
- The Fairgrounds pickleball/tennis renovation will be added to June's Parks Commission Agenda for discussion.

# **HWY 100 Medians Maintenance:**

- John Nilges, Darren Lamb, and Wayne have had discussions on how to rectify the medians.
  They came up with a plan to present to City Council on why native plants are good and how to
  educate the public on the benefits of native plants, how Stormwater funds could be used to
  help offset the contractor cost to maintain the medians, in addition to the traffic benefits that
  the medians bring. Council rejected the bid and decided they did not want to spend any more
  money on making the medians look better when most people do not want them there.
- The City will be forming a committee to review options (different plants, completely removing the medians etc.). In the meantime, Parks Staff will continue to maintain them as best they can.
- The medians cost the city around \$11,400 a year to maintain. If the Irrigation system is used, the cost is approximately \$16,000.00
