Re: Request for Assistance, Flood Plain Management Systems (FPMS)

The City of Washington would like to respectfully submit this letter of support for FPMS funding to pursue hydraulic modeling to assess the flooding problem and a potential levee located approximately at mile marker 68 on the north side of the Missouri River. The area in question is prone to flooding with significant impact to Washington, Missouri and the surrounding area. Some of the potential benefits to removing this area from the floodplain and into a protected area include but are not limited to the following:

- 1. Protection of Highway 47. In 2019, the City, MODOT, and the Federal Government completed construction on a \$63 Million bridge over the Missouri River. During periods of high-water access to the bridge is cut off. Many businesses utilizing the bridge must close from lack of employees having access to work and from goods and services not being able to utilize Highway 47. The closest detour would be to access the Herman, MO Bridge adding 60 miles and an hour of drive time. A levee system would protect Highway 47 and the recent investment of new bridge infrastructure keeping access open during high-water.*
- 2. Continuous Operation of the Washington School District. The Washington School District, the third largest district in the state in relation to physical size, also covers areas on both sides of the river, causing the schools to close during flooding events. A levee system would protect Highway 47 and the recent investment of new bridge infrastructure keeping access open during high-water.*
- 3. Protection of the Washington Regional Airport. The City of Washington owns and operates the municipal airport (FYG) just north of the Missouri River at 12958 Highway 47. The airport consists of a terminal, 44 hangars, and 5,000 ft runway. The City was recently awarded \$3 million from the Federal Omnibus Bill to increase the runway length and width and allow for increase business use for the region. A levee could not only protect the existing infrastructure but the soon to be additional federal investments as well.*
- 4. Provide Access from Washington to the Katy Trail. The nation's longest continuous recreational rail trail, The Katy Trail, runs adjacent to the airport property. Being*

the largest City in Franklin County, Washington has much to offer the riders along the Katy Trail. Washington also has a large existing trail network that could benefit by connecting directly to the Katy Trail. A trail was added to the new bridge in 2019, but ends with the bridge infrastructure. A trail could be placed on top of the levee connecting the City to the Missouri State Park system with access to the Katy Trail. Furthermore, the State has announced funding for development of the Rock Island Trail south of the Missouri River. The connection, via the Hwy 47 bridge, is the obvious point to link the two trail systems together.

- 5. Protecting Farmland and Leveraging Additional Development. The development of a levee could bring approximately 2200 acres out of the floodplain protecting existing farmland and open land up for development. The City owns 500 acres that could have protected runway access for industrial development. The remaining privately owned land would be protected farmland and valued much higher should the owners decide to develop.*

It should be noted that at one point a causeway was proposed to connect Highway 47 to Highway 94. This solution was estimated in 2017 to cost upwards of \$70 million and would keep the bridge open during high-water and provide trail access. This solution, however, would not protect the Washington Regional Airport or the 2,200 acres still in the floodplain. We feel an investment of that size should leverage additional development, and a levee meets that goal while potentially investing less money. An exhibit of this proposal is attached.
