## OLD BUSINESS:

4A 23-02-0004 Pedestrians in and around traffic: This item was closed during a previous meeting, however it is being left on the agenda so that the committee can monitor the situation. Nothing new was reported at this meeting. (OPEN)

## NEW BUSINESS:

5A 23-05-0012 Sidewalk near train depot: Andrea Lueken briefed the committee on future plans for sidewalk improvements along Front Street in the coming years. The committee discussed the sidewalk and street in front of the train depot specifically. The committee agreed that when the scheduled improvements are made, it would be best to remove the current loading area in front of the depot to widen the sidewalk. This will create a consistent street edge along Front Street. (CLOSED)

5B 23-05-0013 Traffic Complaints on South Bend Drive: The committee reviewed the parking situation along South Bend Drive near the new WHS Baseball Fields. Since the fields

have opened, there has been a significant increase in on street parking during games. The committee agreed that a no parking zone along the radius of the curve on South Bend Drive in that area made sense to prevent crashes. The committee did not recommend any further changes and noted that it is only expected that parking will be heavy around 40 days per calendar year. Engineering will draft the proposed parking restrictions for council approval. (CLOSED)

5C 23-05-0014 Stop sign request at 4<sup>th</sup> and Elm: This request came from a local business owner. Engineering took a look at the intersection and agreed that a sight distance issue existed when vehicles are parked on Elm Street near the intersection. The committee also noted that every other similar intersection in the area was currently a 4 way stop. The committee agreed to add a 4 way stop at this intersection as well. Engineering will forward the ordinance to council for approval. (CLOSED)

5D 23-05-0015 Stop sign review for Highland Meadows Subdivision: The committee reviewed a stop sign package for the new Highland Meadows development as well as some existing streets in Autumn Leaf. The committee agreed to ask the developer to install stop signs at the following locations:

Koch Lane, approaching Bieker Road from the North Youngfield Circle, approaching Koch Lane from the East Grit Court, approaching Robbit Trail Drive from the East Koch Lane, approaching Rabbit Trail Drive from the West Rabbit Trail Drive, approaching Bieker Road from the North Peyton's Place Avenue, approaching Rabbit Trail Drive from the East Ellerslie Way, approaching Rabbit Trail Drive from the East Crewe Court, approaching Rabbit Trail Drive from the East Jacqueline Drive, approaching Anniston Drive from the East Jacqueline Drive, approaching Marquart Drive from the West Sophia Drive, approaching High Street from the East Walter Way, approaching High Street from the East Greta Court, approaching Sophia Drive from the North

Engineering will also forward this item to council for approval. (CLOSED)

5E 23-05-0016 Street closure requests: The committee reviewed and approved street closure requests for the following events:

WHS Senior Parade Borgia Grade School Field Day Art and Wine Fest Holiday Parade of Lights Fall Festival Corpus Christi Farm to Table Cajun Fest Fair Parade and Fair Pumpkin Palooza Old Fashioned Christmas
