City of Washington Parks & Recreation AFTER-HOURS POOL RENTAL RULES

Revised 5/11/2023

Fee: \$ 600 + 200 Damage Deposit

Day/Time: Saturday & Sunday's from 7-9 pm

Not Allowed:

- Alcoholic beverages are prohibited in the pool or pool grounds, including the pool parking lot.
- Glass containers of any type are strictly prohibited.
- Any food or drink on the pool deck. All food and drink must stay in the concession area.
- Tobacco Products/E-Cigarettes & Chewing Gum.
- Any Non-approved US Coast Guard devices such as Water Wings.

Allowed:

- Cake, Cupcakes, or cookies.
- Outside food (*Must have Parks & Recreation Department approval*).
 - No refrigeration or warming available.
 - All food must stay in the concession area.
- Please Provide your own plates/utensils/napkins/cups.
- Tablecloths (Please provide your own. There are Three Round Picnic Tables).

Pool Rules:

- The individual signing the Rental Agreement shall be present at the rental.
- The City of Washington reserves the right to inspect any and all packages that are being brought into the pool area.
- All Pool rules and regulations listed at the pool must be followed.
- Responsible for the behavior of all guests. Parental supervision is required. A 10 to 1 ratio of children (under the age of 10) to adults is required.
- No running on the pool deck.
- No abusive or vulgar language.
- No throwing or pushing people into the water and no horse-play in the water.
- No sitting, standing, or jumping off the lifeguard stands.
- Questions should be directed to the Pool Manager or their designee and not lifeguards that are guarding the pool.

Cancellation Policy:

- A minimum of two weeks' notice is required for cancellations, and all cancellations must be made during normal office hours which are Monday-Friday 8 am to 5 pm.
- Cancellations by renter two weeks prior to rental date will receive refunds less a \$25 Administrative Fee. Cancellations received with less than two weeks' notice will be refunded 50% of the total rental less a \$25 Administrative Fee. This applies to all cancellations not initiated by the City.
- If the City closes the pool due to inclement weather, no cancellation fee will be charged. Every effort will be made to reschedule a rental when canceled due to weather.
- If a rental is underway and reaches the halfway point, no refunds will be given due to inclement weather. If the rental has not reached the halfway point and the pool closes due to inclement weather, the remaining time may be rescheduled, or a pro-rated refund may be issued.
- Rentals will be canceled for inclement weather if, at the sole discretion of the pool manager, it is raining hard enough to impact the ability of the guards to see the bottom of the pool or if lightning strikes in the area. The pool may re-open after 30 continuous minutes of no lightning strikes in the area.
- Each rental will be reviewed on an individual basis.
