The Mayor read the Arbor Day Proclamation to the kids and talked about the importance of trees and the earth.

- b. Memorial Tree Program Tree Options the Council suggested a small group of trees that would likely do well in our park system. Divided Trees up into Flowering and Shade groups. Flowering list includes Dogwood, Magnolia, Redbud, Cherry, Fringe Tree and Buckeye. Shade list includes Maples, Oaks, Birch, Elm, Tulip, Cypress, Locust, Plantains, Ginkgo and Yellowwood. These would be the suggested trees for our Memorial Tree Program that is about to be relaunched.
- c. Woolley suggested that someone look at the creek in Tiemann Valley. The creek bank could use some bank stabilization since there are tree roots exposed. He suggested stormwater funds could be an option for funding.
